### **MINUTES OF MEETING HELD ON 5 APRIL 2018**

#### **MATTERS ARISING**

**20mph Speed Limit Proposal:** nothing further to report.

**SSE VISTA Project:** Jenna Black and Evan Smith explained that as part of the Vista Project (Visual Impact of Scottish Transmission Assets), SSE are applying to Ofgem for removal of the overhead lines in two areas of Cairngorms National Park.

The proposed areas for removal of overhead lines are between the substation east of Boat of Garten and Docharn (approximately 4km and 16 pylons) and between the same substation east of Boat of Garten to Ballifurth at the edge of the Craigmore wood (approximately 7km and 32 pylons). These lines were chosen because they met the core principles of the project i.e work must not impact the network, removal of the lines would greatly enhance the appearance of the area while not negatively impacting the environment and the socioeconomics of the area.

CNPA, Highland Council, SEPA and SNH have all been involved in discussions and now SSE are consulting with Community Councils. There will be a community public information event before SSE submit the application to Ofgem for funding.

**Public Toilets:** Money received for the Comfort Scheme from HC has decreased from £3400 to £2400 per year and it will be difficult to continue to offer this service. D Carrott is discussing the situation with Cllr Lobban.
